You need three things in the theatre — the play, the actors and the audience, and each must give something.

# Why Become a Nonprofit Corporation?

An important reason is to protect our Officers. One of the most important properties of a corporation is what is called the "corporate veil." The corporate veil protects the officers of the corporation from actions of the corporation. For example, if someone sues the corporation or if the corporation has financial problems and can't pay its bills, the officers are not personally at risk. Most states have statues that protect the officers of nonprofit corporations for decisions they make on behalf of the corporation as long as the decisions were made in good faith to further the health & purpose of the Corporation using the same degree of care that officers would use making major decisions in their personal life.
