General Meeting February 21, 2013

Meeting called to order by President Walt Meyer at 7:00 PM. All Board members present except Activities Chairperson Art Moscatello. There were a total of 30 HHLTers in attendance.

Secretary Bill Harrison report: Get well cards were sent to Arlene Maroney and Louanna Breeder. Minutes from January approved.

Treasurer Mary Glascock reported a balance as of Feb 12, 2013 of \$10,792.57. Dues collected to date were \$335. Dues for 2013 in the amount of \$10 are required now. Checks/cash can be given to her directly or mail your checks to her at 13405 Brogue Court by February 28, 2013.

VP Kathryn Schmiel reported the play is going well; additional report to be given by directors. Anyone interested in directing a play in the fall should contact Kathryn ASAP. The fall dates are Oct 9-10-11. Kathryn has many plays in the HHLT library for review by prospective directors.

Co-directors Walt Meyer and Betty Hitchcock report: the play dates have now been set for May 1-2-3. The first two dates will be open seating at \$10/person. May 3rd will be a Friday dinner theater at \$30/person; the dinner will be a Chinese plated dinner. The play is going well and actors are expected to be off book by Sunday, Feb 24th. Tickets will go on sale in early April.

President Walt Meyer's report: Louanna Breeder is back home now and recovering. Walt said he would check into providing food for the Breeder's; their daughter was heading this effort.

Walt passed a sheet around in Art's absence for members to sign up for the birthday party event on March 21st. Also asked those who might want to perform for the event to sign as well. Working with Elena Portoles, the HHLT was able to repair previous damages due to anchoring the set with in-house help (Walt and Ted Day). Elena has also approved a permanent anchoring board to be installed by HHLT for future productions.

Membership Chairperson Joan Patton introduced two visitors who were checking out the HHLT: Bob and Valerie Bowman. Please encourage them to join our fun group.

Member At-Large Tom Taggart reported the current sound board is at its maximum capacity and is hard wired so nothing further can be done. Additionally, our small stage cannot accommodate more microphones without disruption of the sound effects. Wireless communications for the stage managers and LSTV have frequency issues but solutions are still being researched.

Old business: Compensation for the Gorzka's has been tabled for more research and will be addressed at the March Board Meeting.

New business: Jack Merelman had surgery today; no further information has been received.
